- Update and discussion of Town Accountant Report

No report has been generated as the Town is closing the books for FY17

Changes in the Finance team:

There is a new Principal Assessor A search is being made for a replacement Treasurer/Collector - Consider and vote on Surplus to Deficit transfers for FY17

Stew Cady moved that \$6,800 be moved from line 251, Dispatch to line 211, Police Department Wages. Mike Swanton Second.

Reason - PD wages are in deficit

Discussion - no discussion

Vote: Unanimous vote in favor of the transfer

Stew Cady moved that \$1,750 be moved from line 241, Inspectional Services to line 221, Fire Department.

Mike Swanton Second.

Reason - Wages are in deficit due to on-call

Discussion – Excess in Inspectional Services as the building inspector generally works less than 15 hrs/wk

Vote: Unanimous vote in favor of the transfer

Stew Cady moved that \$14,359 be moved from line 155, Computer Operations to line 122 Selectmen's expenses.

Mike Swanton Second.

Reason – PD investigation (The White Report) ~\$8,000 and Rec Department Control Audit ~\$6,000. Computer Operations has funds available as spending in the department is event driven and there were fewer events than anticipated.

Discussion – There is an ongoing dispute with the Risk Management Advisors report that may require additional funds in the future. Bryan Sawyer requested that FinCom be provided a copy of the Recreation Department Control Audit.

Vote: Unanimous vote in favor of the transfer

Stew Cady moved that \$2,431 be moved from line 141, Assessors to line 192, Public Buildings. Mike Swanton Second.

Reason – Public Buildings account in deficit due to maintenance problems during the year Discussion – no discussion

Vote: Unanimous vote in favor of the transfer

Stew Cady moved that \$900 be moved from line 176, Land Use to line 292, Animal Control. Mike Swanton Second.

Reason – Prior year bills and boarding costs in excess of appropriation

Discussion - no discussion

Vote: Unanimous vote in favor of the transfer

Stew Cady moved that:

\$36,079.97 be moved from line 422, DDPW wages and expenses \$1,820 be moved from line 424, street lights \$4,819.12 be moved from line 426, grounds and maintenance \$2,968.01 be moved from cemeteries For a total transfer of \$45,687.54 to line 423, Snow and Ice

Mike Swanton Second.

Reason - Snow and Ice deficit to be covered by general fund excess

Discussion – DPW wages were low due to some funding by snow and ice during the Winter. Patrice to follow up on cemeteries as budget discussions indicated that cemeteries are not able to self fund.

Vote: Unanimous vote in favor of the transfer

Stew Cady moved that \$2,200 be moved from line 750, Debt to line 611, Library Wages. John O'Keefe Second.

Reason – Library Wage Accout is deficit, Library Directory stated that longevity was not budgeted in 2017 wages.

Discussion - no discussion

Vote: 3 votes in favor of the transfer, 1 vote against the transfer.

- Consider and vote on Reserve Find Transfer requests for FY17

There is no need for transfers from the reserve fund at this time.

The surplus of \$20,000 will become free cash
