Greetings:
In the name of the Commonwealth aforesaid, you are hereby required to notify and warn the Inhabitants of said Town, qualified to vote in Town affairs, to assemble in Meeting Room A\&B of the Shirley Town Hall at 7 Keady Way in Shirley on Monday, the fifth day of November 2018 at 6:00 p.m., to consider the following:

## ARTICLE 1: Transfer of Stabilization Funds

Shall the Town vote to transfer the sum of $\$ 89,297.00$ from Stabilization Fund to the General Fund for the purpose of correcting an appropriation relating to the Ayer Shirley Regional School District budget from the May 14, 2018 Annual Town Meeting; or take any other action relative thereto.

Summary: This Article is necessary to set the annual tax rate. At the Annual Town Meeting on May 14, 2018 the Town reduced the Ayer Shirley Regional School District's (ASRSD) budget by a total of $\$ 173,843.00$. After clarification, it was determined the ASRSD was entitled to the $\$ 173,843.00$. Of that amount, $\$ 89,297.00$ must be moved from the Stabilization Fund to the General Fund line item.
