In the name of the Commonwealth aforesaid, you are hereby required to notify and warn the Inhabitants of said Town, qualified to vote in Town affairs, to assemble in the Auditorium of the Ayer-Shirley Regional Middle School at 1 Hospital Road in Shirley on Monday, the Eighth day of June, 2015 at 7:00 p.m., to consider the following:

Article 1: Amend Operating Budget for FY 2016 (Appendix A)

To see if the Town will amend the FY2016 Operating Budget as previously appropriated under Article 6 of the April 27, 2015 Annual Town Meeting as set forth in Appendix A; or take any other action relative thereto.

Summary: When the 2015 Annual Town Meeting was adjourned on April 28, 2015 the budget was left unbalanced. The FY 2016 general government and the regional school budget lines require additional appropriation. Town Meeting will then be asked to fund all the lines of the FY2016 Operating Budget.

A majority vote is required for the passage of this article, unless transferring funds from the Stabilization Fund, in which case a 2/3 vote is required.
