Discussion of Stormwater on Lancaster Road near the Thrive Project Site (currently under construction) and the Lancaster Town Line.

- Summary of the condition of the municipal infiltration structures alongside Windsor Road.
  - 6 catch basins on Windsor Road (municipally-owned) have been cleaned out.
  - DPW is currently cleaning out the infiltration basins
  - The infiltration basins are near an underground high voltage line, so digging into the ground there to clean the rocks out of the pipes and to clean the rocks out of the collection box
  - $\circ$  5 5x10 distribution boxes.
